## EXECUTIVE SUMMARY

Senate Bill 233 (SB 233) was enacted during Nevada's 83<sup>rd</sup> Legislative Session and became effective on July 1, 2025. The legislation directs the Council on Food Security to conduct a study of long-term sustainability of the Home Feeds Nevada Agriculture Food Purchase Program and submit its findings by December 1, 2026.<sup>1</sup>

### REQUIREMENTS ([SB233](#), [NRS 561.505](#), & [NRS 561.515](#))

Pursuant to SB 233, the Council on Food Security may request the drafting of one legislative measure (Bill Draft Request [BDR]) related to the Home Feeds Nevada Agriculture Food Purchase Program. The request must be submitted to the Legislative Counsel on or before December 1, 2026, using the form prescribed by the Legislative Counsel Bureau (LCB).<sup>1</sup> An allocation of \$800,000 has been established in accordance with Nevada Revised Statutes (NRS) [561.505](#) and is allocated from the state general funds to the Director of Nevada Department of Agriculture (NDA) for Home Feeds Nevada Agriculture Food Purchase Program (HFNAFPP) as per [NRS 561.515](#).<sup>1,2</sup> The remaining funds from this appropriation will not be available after June 30, 2027, for the entity that received the appropriation or any entity that acquires funds from it in any way. Additionally, any unspent funds must not be utilized for any purpose after September 17, 2027, by either the original entity or any subsequent entity that received the funds and must be returned to the state general fund by September 17, 2027.

### Legislative Background

Food insecurity continues to affect communities throughout Nevada, with many households experiencing limited or uncertain access to sufficient, safe, and nutritious food.<sup>3</sup> While federal nutrition assistance programs remain an essential component of the food assistance network, state and local initiatives also play an important role in strengthening food systems, supporting agricultural producers, and improving access to nutritious foods.

Recognizing the importance of strengthening Nevada's local food system, the Nevada Legislature established HFN during the 81<sup>st</sup> Legislative Session through Senate Bill (SB) 370, codified in NRS [561.505–561.515](#), inclusive.<sup>4,5</sup> The program is administered by the Nevada Department of Agriculture (NDA) and was created to increase the purchase of Nevada-grown and Nevada-produced food while improving access to nutritious foods for food-insecure households. Through partnerships with Nevada agricultural producers, processors, and the state's two regional food banks, the program supports both local agriculture and food distribution efforts throughout Nevada.<sup>5</sup>

During the 83<sup>rd</sup> (2025) Legislative Session, the Nevada Legislature enacted Senate Bill 233 (SB233), which, among other provisions relating to agriculture, appropriated additional general fund support for HFN. In conjunction with this legislative action, the Council on Food Security (CFS) was directed to evaluate the long-term sustainability of the program during the 2025–2026 interim. The Council's study focuses on understanding the operational, financial, and administrative factors that influence the program's ability to continue serving Nevada communities while supporting the state's agricultural economy.<sup>1</sup>

## PURPOSE OF THIS REPORT

According to SB 233, the purpose of the report is for CFS to conduct a study that minimally identifies sustainable sources and revenue for HFN. This report is required to be submitted to the Director of NDA and the Director of LCB for forwarding to the 84<sup>th</sup> Session of the Legislature.<sup>1</sup> This report documents the Council on Food Security's study activities conducted pursuant

to SB 233 during the 2025–2026 interim. The report summarizes information reviewed by the Council, including program operations, annual program reports, partner input, available program data, and discussions regarding long-term sustainability.

Consistent with the Council's statutory responsibilities, the study examines topics including program administration, procurement practices, funding, partnerships, operational considerations, and approaches used by comparable programs in other states.<sup>5</sup> The purpose of the report is to provide the Legislature with an objective summary of information reviewed by the Council and to document the status of the study as of the publication of this draft.

Because the Council's work remains ongoing, this document should be considered an interim draft. Additional partner engagement, review of funding models, and Council discussion are anticipated during future meetings. As additional information becomes available and the Council completes its study, future drafts of this report may be updated to reflect new information, findings, and any formal recommendations adopted by the Council.

### Council on Food Security

The Nevada Council on Food Security was established to coordinate statewide efforts to improve food security, strengthen collaboration among public and private partners, and advise state leadership on issues affecting food access and nutrition.<sup>6</sup> The Council brings together representatives from state agencies, food banks, agriculture, education, health care, community organizations, retailers, and other sectors to identify strategies that improve Nevada's food system and reduce food insecurity.

As part of its responsibilities under SB 233, the Council established a subcommittee to guide the study of HFN. Throughout the study process, the subcommittee reviewed annual program reports, engaged with representatives from the NDA and other interest holders, examined available program data, and discussed operational considerations affecting the program's long-term sustainability.<sup>7</sup> These activities informed the preliminary findings presented throughout this report.

## Background

### Food Security and Local Food Systems in Nevada

Food security is achieved when all people, at all times, have physical, social, and economic access to sufficient, safe, and nutritious food that meets their dietary needs and food preferences for an active and healthy life.<sup>8</sup> While Nevada relies heavily on national and international food supply chains, strengthening local food systems has become an increasingly important strategy for improving food security, supporting agricultural producers, and increasing community resilience.

Nevada imports the majority of its food from outside of the state, making the food system vulnerable to disruptions in transportation, supply chains, labor availability, and market conditions. Recent events, including the COVID-19 pandemic, highlighted the importance of strengthening local food production and distribution networks while improving access to nutritious foods for food-insecure households. These challenges have reinforced statewide efforts to support Nevada producers while expanding access to locally grown and produced food through community partnerships.<sup>7</sup>

The Nevada Food Security Strategic Plan identifies strengthening local food systems, expanding access to nutritious foods, and supporting agricultural partnerships as important components of improving statewide food security. These priorities align with broader public health efforts to increase access to healthy foods while strengthening Nevada's agricultural economy.<sup>7</sup>

### Home Feeds Nevada Agriculture Food Purchase Program

HFN was established during the 81<sup>st</sup> Nevada Legislative Session through Senate Bill 370 and is codified in NRS [561.505](#) through [561.515](#), inclusive.<sup>2,3</sup> The program is administered by the NDA and is designed to increase purchases of Nevada-grown and Nevada-produced food while improving food access for Nevada households experiencing food insecurity.

Unlike traditional food assistance programs that primarily purchase food through national distribution systems, HFN emphasizes purchasing directly from eligible Nevada agricultural producers and processors. Through this approach, the program seeks to achieve two complementary objectives:<sup>6</sup>

- Increase access to nutritious food for food-insecure Nevadans.
- Create economic opportunities for Nevada farmers, ranchers, and food processors by expanding markets for locally produced food.

Food purchased through the program is distributed through Nevada's two regional food banks, Three Square Food Bank and the Food Bank of Northern Nevada—which coordinate distribution to partner agencies and communities throughout the state.

### Program Administration

The NDA administers HFN and is responsible for overseeing producer eligibility, food procurement, financial administration, and annual reporting requirements established in [NRS 561.515](#).<sup>3</sup>

According to information provided by the NDA, participating producers and processors must satisfy established eligibility requirements before participating in the program. Applications are reviewed through a standardized eligibility review process conducted by a two-person review committee. Eligibility verification includes confirmation of State vendor registration, a federal Unique Entity Identifier (UEI), and applicable Nevada producer certification or livestock assessment documentation. Applications that do not contain all required documentation remain incomplete until the necessary information is provided.<sup>6</sup>

Rather than utilizing traditional procurement contracts, the program purchases food through Requests to Purchase (RTPs). The NDA reported this procurement approach was adopted because traditional contracting requirements created administrative challenges for many small agricultural producers and did not align with the rapid purchasing timelines often necessary for fresh agricultural products. The RTP process allows the program to respond more efficiently to seasonal production and food bank demand while reducing administrative burden on participating producers.<sup>6</sup>

### Program Funding

Since implementation HFN has been supported through multiple funding sources. Initial program operations were funded through the United States Department of Agriculture Local Food Purchase Assistance (LFPA) Program and State American Rescue Plan Act

(ARPA) funding.<sup>4,9</sup> During the 2025 Legislative Session, the Nevada Legislature appropriated an additional \$800,000 from the State General Fund to the Nutritious Food Purchase Account to support continued operation of the program.<sup>1</sup>

For the reporting period of October 1, 2023, through September 30, 2024, NDA reported approximately \$3.30 million in program expenditures. Approximately 98% of reported expenditures supported direct food acquisition, while comparatively smaller amounts supported transportation and contract program management.<sup>4</sup>

### Program Goals

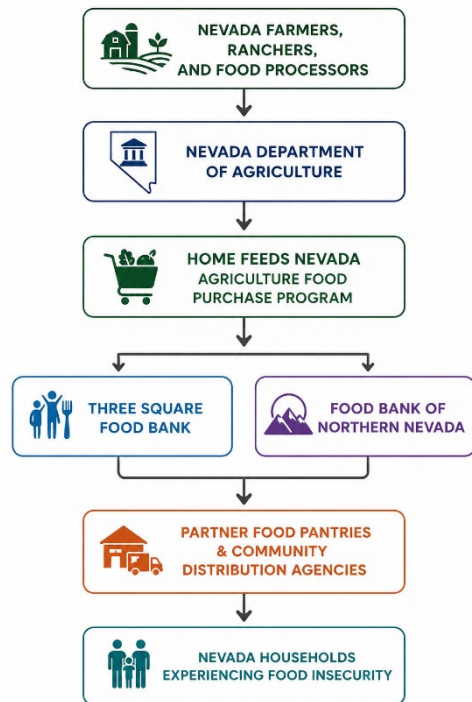
HFN was established to support both public health and agricultural objectives by strengthening connections between Nevada producers and organizations serving food-insecure households. As implemented, the program seeks to:<sup>3,6,7</sup>

- Increase the availability of nutritious, locally produced food.
- Support Nevada farmers, ranchers, and food processors through expanded purchasing opportunities.
- Improve resilience within Nevada's food system.
- Strengthening partnerships among state agencies, agricultural producers, and food banks.
- Expand access to fresh and nutrient-dense foods for households experiencing food insecurity.

HFN operates through a collaborative statewide network connecting Nevada agricultural producers with organizations that distribute food to households experiencing food insecurity. NDA administers the program by coordinating food purchases from eligible Nevada producers and processors, while the state's two regional food banks facilitate distribution through their established networks of partner agencies. Figure 1 illustrates the general flow of food products through the HFN Agriculture Food Purchase Program.<sup>4,6</sup>

The Nevada Department of Agriculture purchases eligible food products from participating Nevada producers and processors for distribution through Nevada's two regional food banks. Food is then distributed through partner agencies to households experiencing food insecurity throughout the state.

## Study Methodology

### Study Purpose

SB 233 directed the Council to evaluate the long-term sustainability of the Home Feeds Nevada Agriculture Food Purchase Program (HFN) during the 2025–2026 interim. To support this effort, the Council established a subcommittee to guide the study, identify information needs, engage with interest holders, and develop a report summarizing the information reviewed throughout the study process. The SB 233 subcommittee membership and leadership are provided in Appendix A.<sup>1,5</sup>

The study was designed to provide an objective assessment of the program's implementation, operations, and sustainability. Rather than evaluating a single policy proposal, the Council examined the administration and performance of an existing statewide program while identifying factors that may influence its long-term success.

### Study Approach

The Council organized its work around four primary study objectives:<sup>5</sup>

1. Interest Holder Engagement – Engage organizations involved in administering, supporting, or participating in the HFN Agriculture Food Purchase Program to better understand program operations, successes, and implementation challenges.
2. Program Operations and Sustainability Review – Examine administrative processes,

procurement practices, funding, transportation, reporting, and other operational factors that may affect the program's long-term sustainability.

3. Review of Funding Models and Comparable Programs – Research funding mechanisms and operational approaches used by similar local food purchasing programs in other states to better understand potential approaches supporting long-term sustainability.
4. Report Development – Compile information reviewed throughout the study into a report documenting the Council's activities, observations, and preliminary findings for consideration during the 2025–2026 interim.

These objectives were developed to organize the Council's review and ensure discussions addressed both current program operations and future sustainability considerations.

### Interest Holder Engagement

Throughout the study, the Council engaged with representatives from organizations directly involved in the HFA and Nevada's broader food system. Discussions focused on understanding program implementation, operational practices, funding, procurement, and distribution processes. Consistent with Nevada's Open Meeting Law (OML), subcommittee meetings were publicly noticed and open to the public, providing opportunities for interested individuals and organizations to observe proceedings and provide public comment.<sup>5</sup>

Interest holders contributing information during the study included, but were not limited to:

- Nevada Department of Agriculture
- Three Square Food Bank
- Food Bank of Northern Nevada
- Nevada Farm Bureau
- Agricultural producers and processors
- Council on Food Security members
- Other organizations identified during the study process

The Council also identified additional organizations and agencies for future engagement as the study progresses.<sup>5</sup>

### Information Reviewed

To support its evaluation, the Council reviewed a variety of documents and data sources, including:<sup>5</sup>

- HFN annual reports prepared by NDA;
- Program operational information provided by the NDA;
- Applicable Nevada Revised Statutes and legislative materials;
- Council on Food Security meeting materials and presentations;
- Information regarding comparable state and federal food purchasing initiatives; and
- Statewide food security planning documents and other publicly available resources relevant to food security and agricultural systems.

The Council supplemented these materials with presentations, discussions, and responses to questions submitted during the study process.

### Study Limitations

The Council's review reflects information available during the period covered by this draft report. Certain information, including additional operational data, funding information, geographic distribution data, and future program performance measures, remained under



review at the time this report was prepared.

In addition, several topics identified by the Council—including long-term funding strategies, transportation considerations, administrative capacity, and comparisons with similar programs in other states—continue to be evaluated as part of the ongoing study. Consequently, the findings presented in this report should be considered preliminary and may be supplemented as additional information becomes available and the Council completes its work pursuant to SB 233.<sup>1,5</sup>

## Home Feeds Nevada Agriculture Food Purchase Program

### Producer Eligibility and Participation

Participation in HFN is limited to eligible Nevada agricultural producers and processors that satisfy program requirements established by the NDA

As of the most recent operational period, 23 Nevada agricultural organizations had participated in the program since its inception, including 15 producers and 8 food processors. During the most recent purchasing cycle, 17 producers and processors actively participated in program activities. All participating farms were classified as small farms according to the United States Department of Agriculture Economic Research Service farm size classifications.<sup>4,11</sup>

### Procurement Process

Unlike many traditional food purchasing programs that rely on long-term procurement contracts, HFN utilizes RTPs to acquire food products from eligible Nevada producers and processors.

The NDA reported that this purchasing model was selected because traditional contracting processes created administrative barriers for many small agricultural producers and were not well suited for purchasing highly perishable food products. The RTP process allows purchasing decisions to occur more quickly while reducing administrative requirements for participating producers.<sup>6</sup>

Program purchases are coordinated closely with Three Square Food Bank and the Food Bank of Northern Nevada. The food banks provide ongoing information regarding current

community food needs, seasonal demand, and product availability. This collaborative process helps ensure that food purchases align with recipient needs while supporting Nevada agricultural producers.

When fresh produce is seasonally unavailable, the program may prioritize other eligible food products, including dairy products, meat proteins, and other nutrient-dense foods requested by food bank partners.

### Food Distribution

Food purchased through HFN is distributed through Nevada's two regional food banks:<sup>4</sup>

- Three Square Food Bank
- Food Bank of Northern Nevada

The food banks coordinate distribution to partner agencies serving communities throughout Nevada. Because these organizations interact directly with recipient households, they also provide annual reporting information regarding households and individuals served through the program.<sup>4</sup>

The NDA reported that procurement decisions are made collaboratively with the food banks to reduce food waste and better match purchases with community demand. During the program's operation, 571 deliveries were accepted, one delivery was rejected, and two deliveries were partially accepted, demonstrating a high level of successful product delivery and quality control.<sup>4,6</sup>

### Program Outputs

Between October 1, 2023, and September 30, 2024, HFN procured and distributed approximately 1.83 million pounds of food through participating food banks.<sup>4</sup>

Table 3 summarizes the progression of the Home Feeds Nevada Agriculture Food Purchase Program from its initial implementation through the most recent reporting periods. Although reporting periods and funding sources varied, the available reports demonstrate continued statewide food procurement and distribution, while illustrating changes in program activity as funding and program operations evolved over time.

Products purchased through the program included a variety of fresh vegetables, fruits, meat proteins, dairy products, and other locally produced foods. Fresh produce included leafy greens, squash, tomatoes, peppers, cucumbers, broccoli, carrots, melons, apples, and other seasonal products grown within Nevada.

### Program Reach

For calendar year 2024, participating food banks reported serving approximately 774,894 households, including:<sup>4</sup>

In addition, annual program reporting identified approximately 1,117,742 individuals served during 2024. The Nevada Department of Agriculture notes that these counts are reported by participating food banks and represent duplicated counts rather than unique individuals or households.<sup>4</sup>

## Long-Term Sustainability Assessment

### Funding Sustainability

Throughout the study process, Council members discussed the importance of understanding how future funding could support continued program operations after current funding sources are exhausted. Discussions included reviewing the structure of existing funding sources, identifying grant opportunities, and examining funding approaches utilized by similar programs in other states.<sup>5</sup>

Examples of funding approaches identified for additional review included:

- State General Fund appropriations;
- Federal grant opportunities;
- Public-private partnerships;
- Retail fundraising initiatives;
- Grant matching opportunities; and
- Other funding mechanisms identified through the Council's review of comparable state programs.

These discussions were exploratory in nature and were intended to inform the Council's understanding of potential funding models rather than establish formal funding recommendations.

### Program Administration and Procurement

The Council reviewed the administrative structure used by HFN, including producer eligibility, RTPs), procurement procedures, and coordination with participating food banks. Information presented during Council meetings indicated that procurement decisions are closely coordinated with participating in food banks to reflect current community demand and seasonal product availability. This collaborative purchasing process helps prioritize fresh produce when available while allowing purchases of other eligible nutrient-dense products, including meat proteins and dairy products, during periods when fresh produce is less readily available.<sup>6</sup>

### Transportation and Distribution

Transportation and distribution logistics were also reviewed as part of the Council's evaluation of program sustainability. Information provided by the NDA indicated transportation costs have historically represented a relatively small portion of overall program expenditures. In many cases, producers deliver products directly to participating food banks. In limited situations, food bank partners have assisted with transportation when existing delivery routes were available.

The Council also discussed transportation challenges affecting certain rural communities, particularly during warmer months when climate-controlled transportation may be necessary to reduce spoilage of perishable products. These discussions highlighted the importance of continued coordination among producers, food banks, and program administrators to support efficient statewide distribution.<sup>4,6</sup>

### Interest Holder Collaboration

A central component of the Council's study involved engagement with organizations participating in or supporting Home Feeds Nevada.

Representatives from the Nevada Department of Agriculture provided information regarding program administration, procurement practices, reporting requirements, and operational experience. Additional discussions included participation from Three Square Food Bank, the Food Bank of Northern Nevada, the Nevada Farm Bureau, agricultural producers and processors, Council members, and other stakeholders with knowledge of Nevada's food system. The Council also identified the Nevada Retail Association as a potential organization for future collaboration regarding funding and program sustainability opportunities.<sup>5</sup>

The Council identified continued engagement with these organizations as an important component of the ongoing study, recognizing that collaboration among program partners contributes to understanding both current operations and future sustainability considerations.<sup>5</sup>

### Review of Comparable Programs

As part of its legislative charge, the Council initiated a review of similar local food purchasing programs operating in other states.<sup>12</sup>

The purpose of this review was to better understand how comparable programs are administered, funded, and sustained over time. Council members reviewed available information regarding state appropriations, federal funding, public-private partnerships,

and other approaches supporting local food purchasing initiatives.<sup>12</sup>

This review remains ongoing and will continue to inform the Council's understanding of potential strategies supporting the long-term sustainability of HFN.

### Data Collection and Reporting

The Council also reviewed existing reporting requirements established in [NRS 561.515](#) and information currently collected through HFN.<sup>3</sup>

Program reporting currently includes expenditures, food purchases, the total pounds of food procured and distributed, and the number of households and individuals served. For the reporting period of October 1, 2023, through September 30, 2024, the Nevada Department of Agriculture reported that Home Feeds Nevada procured and distributed approximately 1.83 million pounds of food through the program.<sup>4</sup> During discussions, the Council identified opportunities to better understand additional operational information, including geographic distribution, transportation logistics, and other program measures that may support future evaluations.<sup>5</sup> The Council's review of reporting practices remains ongoing and will continue as additional information becomes available through annual reporting and partner engagement.<sup>5</sup>

## Preliminary Findings

### Overview

The findings presented in this chapter summarize information reviewed by the Council on Food Security during the 2025–2026 interim pursuant to SB 233. These findings reflect information available at the time this draft was prepared and are intended to document observations that emerged throughout the Council's study of the HFN Agriculture Food Purchase Program.<sup>1,5</sup>

As the Council continues to engage interest holders, review additional information, and evaluate comparable programs, these findings may be revised or expanded in future drafts of this report.

#### **Finding 1.** HFN Has Established a Statewide Procurement and Distribution Framework

The Council found that HFN established an operational framework connecting Nevada agricultural producers and processors with Nevada's two regional food banks through coordinated food purchasing administered by the NDA.

#### **Finding 2.** Program Operations Depend on Strong Collaboration Among Multiple Organizations

The Council observed successful implementation of HFN depends upon collaboration among numerous public and private organizations.

NDA administers the program and coordinates procurement activities. Three Square Food Bank and the Food Bank of Northern Nevada identify food needs within their service areas and distribute purchased food through local partner agencies. Agricultural producers and processors supply eligible food products, while the Council provides oversight through its study activities.

#### **Finding 3.** The Program Has Demonstrated Measurable Operational Activity

Information reviewed by the Council demonstrates that Home Feeds Nevada has supported

significant food purchasing and distribution activities since implementation. During October 1, 2023, through September 30, 2024, reporting period, NDA reported:

- Approximately \$3.3 million in total program expenditures.
- More than 1.8 million pounds of food procured and distributed.
- Approximately 774,894 households served.
- Approximately 1.1 million individuals served.
- Participation from 23 Nevada producers and processors.

These measures demonstrate the operational scale of the program and provide an initial basis for evaluating future program performance.<sup>4</sup>

#### **Finding 4. Long-Term Funding Remains a Primary Area of Study**

Throughout the Council's review, long-term funding sustainability emerged as one of the primary topics discussed by members and participating interest holders.

The Council reviewed current funding sources supporting Home Feeds Nevada, including the United States Department of Agriculture Local Food Purchase Assistance (LFPA) Program, State American Rescue Plan Act (ARPA) funding, and General Fund appropriations. Members also began reviewing funding mechanisms utilized by comparable programs operating in other states.<sup>4 5 9</sup>

To date, the Council has identified several preliminary considerations for further evaluation, including:

- Continued reliance on recurring State General Fund appropriations;
- Pursuit of additional federal grant opportunities and required matching funds;
- Public-private partnerships and philanthropic funding opportunities;
- Retailer and consumer donation models, such as voluntary "round-up" campaigns;
- Opportunities to leverage existing state grant programs and matching fund initiatives; and
- Potential administrative capacity needs to support long-term program coordination and grant management.<sup>5</sup>

During these discussions, members identified the Nevada Retail Association as a potential partner for exploring voluntary customer "round-up" campaigns and other retailer-supported fundraising opportunities that could supplement future program funding. These concepts remain under evaluation and have not been adopted as formal recommendations.

#### **Finding 5. Transportation and Distribution Logistics Influence Program Implementation**

The Council identified transportation and distribution as important operational considerations affecting statewide program implementation.

Information reviewed during the study indicated that transportation costs currently represent a relatively small portion of reported program expenditures. However, discussions also identified logistical considerations affecting rural communities and the transportation of perishable food products, particularly during warmer months.

The Council will continue reviewing how transportation infrastructure and distribution practices may influence long-term program sustainability.<sup>4,6</sup>

#### **Finding 6. Existing Reporting Provides Important Performance Information While Additional Data May Support Future Evaluations**

The Council reviewed annual reporting submitted by the Nevada Department of Agriculture pursuant to [NRS 561.515](#).<sup>3</sup>

Current reporting includes expenditures, food purchases, and the number of households and individuals served. Throughout the study, members also discussed opportunities to better understand additional operational information, including geographic distribution, transportation activities, and other measures that may further support future program



evaluations.

#### **Finding 7. Evaluation of Comparable State Programs Remains Ongoing**

The Council initiated a review of local food purchasing programs operating in other states to better understand approaches supporting long-term sustainability.

This review includes examining funding mechanisms, administrative structures, procurement practices, and partnerships utilized by similar programs. Information gathered through this review is intended to inform the Council's understanding of Home Feeds Nevada and does not represent an endorsement of any particular funding model or administrative approach.<sup>12</sup>

Additional review of comparable state programs is anticipated during the remainder of the study period.

## **Conclusion**

Pursuant to SB 233, the Council on Food Security initiated a study of the HFN Agriculture Food Purchase Program during the 2025–2026 interim to better understand factors affecting the program's long-term sustainability. Throughout the study, the Council reviewed annual program reports, operational information, partner input, and available program data to better understand how the program functions and the considerations that may influence future implementation.<sup>1,5</sup>

Information reviewed during the study demonstrates that Home Feeds Nevada has established an operational framework supporting the procurement and distribution of locally produced food throughout Nevada. Annual reporting also demonstrates measurable program activity, including food purchases, producer participation, and statewide distribution through Nevada's two regional food banks.<sup>4</sup>

The Council's review also identified several topics that warrant continued evaluation, including long-term funding, transportation and distribution logistics, administrative capacity, program reporting, and approaches utilized by comparable programs operating in other states. These topics continue to inform the Council's understanding of the program and will be further evaluated as the study progresses.

This report reflects information available at the time of drafting and is intended to document the Council's work completed to date. As additional information becomes available and the Council continues its evaluation pursuant to SB 233, future drafts may incorporate additional analyses, findings, and any formal recommendations adopted by the Council.<sup>1</sup>

#### **Future Council Activities**

The Council's study of the HFN Agriculture Food Purchase Program remains ongoing. During the remainder of the 2025–2026 interim, the Council anticipates continued engagement with interest holders, additional review of program data, and continued examination of funding and operational approaches that may support long-term program sustainability.<sup>5</sup>

Future Council activities are expected to include:

- Continued review of Home Feeds Nevada operational data and annual reports.
- Additional engagement with the NDA, food banks, agricultural producers, processors,

and other interest holders.

- Continued examination of funding models and administrative approaches utilized by comparable programs in other states.
- Review of additional information related to transportation, distribution, and other operational considerations affecting program sustainability.
- Development and refinement of findings and, if appropriate, consideration of potential recommendations for future Council action.

Consistent with the Council's statutory responsibilities, future revisions to this report will incorporate additional information reviewed during the study and reflect any actions formally adopted by the Council before submission of the final report to the Legislature.<sup>1,5</sup>
